FAIRFIELD, Calif. – For the first time in over 20 years, Partnership HealthPlan of California (PHC) has a new CEO. On Wednesday, July 1, Elizabeth Gibboney took over the reins as CEO of the 530,000 member Northern California Medi-Cal managed care plan.

Ms. Gibboney's leadership, expertise in delivering health care, and her intimate knowledge of PHC operations and culture distinguished her as the best person qualified to lead PHC."

Additionally, Ms. Gibboney was instrumental in PHC's successful planning for the impacts of the Affordable Care Act that included a large influx of new members. Since 2012, PHC's members has more than doubled.

"PHC is a special organization that has a history of being an industry leader in implementing care that prioritizes our members first," said Ms. Gibboney. "Our three-year strategic plan focused on High Quality Health Care, Operational Excellence, and Financial Stewardship is a blueprint for ensuring that our members continue to get the quality care they deserve."
